Executive Director's Report

Our Winter Meeting on Friday, December 17, 2010 at the University of Connecticut was a huge success. A big thank you to the UConn Student Chapter members in coordinating this effort. According to the evaluation forms we received, the theme of *From Rain to Runoff* was very timely and well received. Almost 50 percent of the attendees came from referrals and promotion of the conference by our co-sponsors. All four presenters received high marks for their presentation and content, as did the tour. The participants rated the Bishop Center and UConn very high and would like to see additional conferences at the same location. Future conference themes suggested include storm water management tour of UConn, additional information on TMDL with presentations by EPA and state water quality agencies, and the downfalls and solutions of low impact development (LID) issues in the field. SWCS Modeling Summit 2011 Advancing the Science of Modeling

March 29-31, 2011 | Denver, Colorado

This meeting will provide a forum to exchange information, discuss opportunities for collaboration, and learn about the advantages and limitations of available data sets for inclusion in current and future models. The target audience for the meeting is modelers and data stewards from federal and state agencies, non-profit organizations, industry, private consulting firms and universities.

Overarching goal: To get model practitioners together to talk about the best way to utilize and integrate available models and data sets to address specific customer conservation/conservation benefit needs. One of the primary concerns of our customers is estimating the site-specific benefits of conservation practices. Modelers must consider the level of precision that is needed for the intended use which may include general conservation planning, program payment support, credit trading support, reports to congress, inside and outside of USDA requests, and policy formulation/regulation.

The meeting will be held at the Denver Renaissance Hotel, with complementary transportation to and from DIA. SWCS has arranged a special rate and room block: \$129/night (plus taxes)

Scholarship Opportunities

The **Donald A. Williams Soil Conservation Scholarship** provides financial assistance to members of SWCS who are currently employed but wish to improve their technical or administrative competence in a conservation related field through course work at an accredited college or through a program of special study. *At least one scholarship, up to \$1,000, is expected to be awarded in 2011.*

The **Kenneth E. Grant Research Scholarship** provides financial assistance to members of SWCS for interdisciplinary graduate-level research on a conservation topic that will extend the SWCS mission of fostering the science and art of soil, water, and related natural resource management to achieve sustainability. *One research scholarship of \$1,000 is expected to be awarded in 2011.*

The **Melville H. Cohee Student Leader Conservation Scholarship** provides financial assistance to members of SWCS who are in their junior or senior year of full-time undergraduate study or are pursuing graduate level studies with a natural resource conservation orientation at a properly accredited college or university. *At least one scholarship, up to \$500, is expected to be awarded in 2011.*

SNEC-SWCS 2010 Winter Conference

On December 17, 2010 approximately 50 people attended the SNEC-SWCS Winter Conference at the UConn Bishop Center. The conference brought together students, educators and professionals to learn more about current topics in natural resource conservation. Under the conference theme "From Rain to Runoff" four speakers were assembled to present the status and results of their current conservation efforts.

Dr. Thomas Morris of the UConn Department of Plant Science and Landscape Architecture spoke on compost end use and explained that phosphorus content can vary 30 fold in composts which makes a nutrient plan essential for responsible use.

Andrew Bohne provided site specific examples of design and implementation of Low Impact Development technology for stormwater management and Green Landscape from his experience as an Ecological Designer/Planner at New England Environmental, Inc. of Amherst, MA.

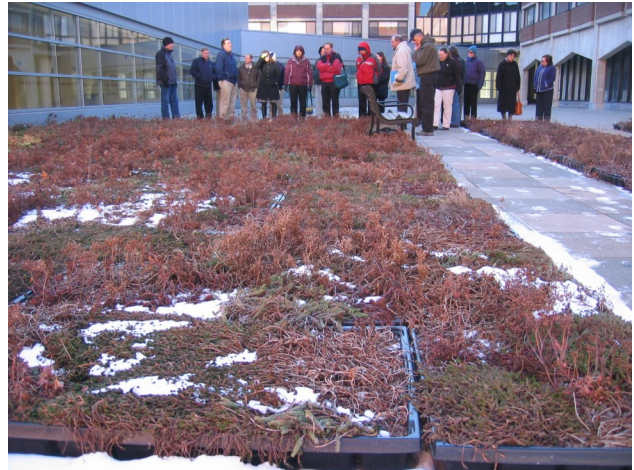
Eric Thomas of the Connecticut DEP presented a detailed account of the nations first Impervious Cover TMDL (IC TMDL) approved by the EPA which is currently being implemented for the Eagleville Brook watershed in Mansfield, CT and on the UConn, Storrs campus. Eric provided an overview of the research approach used in development of the IC TMDL and presented a summary of implementation, with highlights of current efforts to reduce directly connected impervious area to meet the 11% IC target.

Bruce Gregoire, PhD Candidate, UConn Department of Natural Resources and the Environment, presented the results of his research into the water quality and water quantity impact of a modular green roof. Bruce also provided a guided tour of the study green roof located on the Edward V. Gant Complex at UConn, Storrs.

The UConn-SWCS played a central role in organizing and hosting the conference. Thanks to UConn-SWCS President, Lauren LeShane for her planning efforts as well as Samantha Robinson, Genevieve Flock and Matthew Punty for their assistance.

Applicants not approved for funding will be notified by the end of July.
